Verification Statement

Scope of Verification Engagement

This Verification Statement is issued to Evergreen Marine Corp. (Taiwan) Ltd.

Nippon Kaiji Kyokai (hereinafter referred to as "the Society") was commissioned by Evergreen Marine Corp.(Taiwan) Ltd. (Head Office location: Taoyuan County, Taiwan; hereinafter referred to as the "the Applicant"), to assure and verify its CCWG CO₂ and SO_x emission data report dated 22nd March 2019 in the Turnkey system (hereafter referred to as "the Report") for the fiscal year 2018 (01st January 2018 to 31st December 2018). The data submission covers the full reporting period and 173 vessels (owned and chartered) operated by the carrier, excluding spot charter vessels hired for less than six months. The scope of work for the verification covers data reported for CO₂ and SO_x and relates to the data used to calculate the direct vessel specific CO₂ emission factors according to the CCWG CO₂ methodology (gram CO₂/ TEU × Km) and SO_x emissions.
